Please bring the children you are registering with you. Each child will go through a skill evaluation process (not try-outs). This is for the purpose of distributing talent as evenly as possible throughout the league.

Boys and Girls will learn skills and drills appropriate with their age and ability. All children registered will receive equal playing time. 2<sup>nd</sup> – 5<sup>th</sup> grade teams will focus on fundamentals of basketball including shooting, passing, dribbling, and teamwork. 6<sup>th</sup> -8<sup>th</sup> grade teams will learn more advanced basketball skills and team concepts. Children will practice one day per week and have one game either Saturday or Sunday.

All children are welcome to register whether you play in a different league or not. We have scheduled the older children in the later afternoons on the weekend so they are able to join in on the fun! We have added a conflict day at registration so they are able to choose a day that may conflict with their schedule. The end of the season will consist of a tournament and a basketball skill competition.

## Practice & Games

- Each team will be assigned one 1 –hour practice on a week night. Practice will be held after 6pm.
- Practices are assigned based on team availability. Please note a day that your child cannot practice on the player information form.
- Practices will begin the week of January 4<sup>th</sup>.
- Each team will play one game per week on Saturday or Sunday. Season runs January through mid-March.
- Game times may vary due to registration numbers:
  - 2nd - 3rd grade girls Saturday 12m – 1pm
  - 2nd -3rd grade boys Sunday 9am - 11am
  - 4th - 5th grade boys Saturday 9am - 11am
  - 4th - 6th grade girls Saturday 2pm - 4pm
  - 6th - 8th grade boys Sunday 12pm - 3pm

## Team Selection:

- NO REQUESTS WILL BE ACCEPTED FOR ANY GRADE LEVEL.
- Skill evaluation (not try-outs) is run for the purpose of distributing talent as evenly as possible throughout the league. As much as we try, this is not a scientific process.
- Every player should attend their skill evaluation at registration on either November 14 or 21 @ Spring Grove Grade School. Registration is available anytime between the hours of 9am-11am.
- Pre-printed forms will be available at registration if you have played in the league in the past.

## **WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT**

Please read this form carefully and be aware that in signing up and participating in Village of Spring Grove Recreation Department Programs, you will be waiving and releasing all claims for injuries arising out of these programs, that you or the other named participants might sustain. The terms "I", "me", and "my" also refer to parents or guardians as well as participants in the programs. In registering for these programs, you are agreeing as follows:

As a participant in these programs, I recognize acknowledge that there are certain risks of physical injury, and I agree to assume full risk of any injuries, damages or loss which I may sustain as a result of participation in any manner, in any and all activities connected with or associated with such programs. I further recognize and acknowledge that all athletic activities involving strenuous exertion or potential body contact are hazardous recreational activities and involve substantial risks of injury.

I agree to waive and relinquish any and all claims I may have as a result of participating in these programs against the Villages, and any and all other participating servants and employees of the governmental bodies and independent contractors, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while participating in these programs. (The parties described in the preceding sentence are referred to as "released parties" in the remainder of this agreement.)

I do hereby fully release and discharge the Villages and the other released parties from any and all claims for injuries, damage or loss, which I may have or which may accrue to me on account of my participation in these programs.

I further agree to indemnify, hold harmless and defend the Villages and any and all other released parties, from any and all claims resulting from injuries, damages, losses sustained by anyone, and arising out of or connected with, or in any way associated with my conduct and the activities of these programs.

I further understand and agree that the terms such as "participation", "programs" and "activities", referred to in this Agreement, include all exercises and physical movements of any nature while I am participating in these programs and further include the provision of or failure to provide proper instruction or supervision, the use and adjustment of any and all machinery, equipment, and apparatus, and anything related to my use of the services, facilities, or premises involved in these programs, and transportation to and from any events. I understand the nature of these programs for which I am registering, and have read and fully understand this Waiver, Release, and Hold Harmless Agreement.
