An Ordinance Amending Chapter 15 Traffic, Section 15.14, Stop Intersections of the Richmond Municipal Code

BE IT ORDAINED by the President and Board of Trustees of the Village of Richmond, McHenry County, Illinois, as follows:

SECTION 1: Section 15.14, Stop Intersections, of the Municipal Code, shall be amended, as follows:

15.14 STOP INTERSECTIONS.

SECTION 4: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
